### Dog increase proposed for Redlands

Deputy mayor Julie Talty has proposed that Council amend their local law to allow more dogs in the Redlands, based on property size.

T h i s m o v e i s incomprehensible considering half of Redlands is designated as 'Koala Areas' and it is widely acknowledged that domestic dogs are one of the key threats to koalas with hundreds killed and maimed across SEQ each year.


With more than 2000 dog related complaints to Redland Council's Animal Management section in the past year, Council risk creating further disharmony in acreage neighbourhoods as many residents move to these areas to enjoy the wildlife and quiet lifestyle.

KAG supports special provision being made for those who own show dogs or are foster carers, however the change does not need to apply across the entire City.

All acreage properties, both small and large, across the Redlands form a vital part of the koala/wildlife corridors.

These corridors contain the important habitat that make up the linkages to areas mapped in Council's 'Wildlife Corridor Plan'.

Redlands has the opportunity to be seen as unique especially considering their branding of 'Naturally Wonderful', rather than trying to simply be on a par with neighbouring Councils?

#### Wellington Point koala walk

KAG members were rewarded with the sighting of three koalas during a recent walk at Wellington Pt that included the Bligh St Conservation Area purchased by Redlands Council in 2018.

It is truly heartening to know the

KAG plantings that have been conducted on this site over the past few years will provide habitat to koalas and other wildlife that inhabit the area.

The Bligh St Conservation Area abounds Hilliards Ck and Geoff Skinner Wetlands and is an amazing example of a critical wildlife corridor containing endangered regional ecosystem



habitat and also home to endangered migratory shorebirds.

It forms the beginning of a major wildlife corridor that connects to other important habitat areas across the Redlands covering both Council and privately owned lands in the northern and southern parts of the Redlands.

To ensure continued protection of these habitats and corridor linkages, it is imperative that Council adopt their Wildlife Connections Plan 2018-2028, as currently some of these areas are not adequately protected under the Redland City Plan.

#### **Koala Watch Program launched**

Redlands IndigiScapes is inviting community members to join their Koala Watch program.

The program is a joint partnership between Redland Council and koala researchers from the Sunshine Coast University.

One of the key goals is to detect early disease in koalas, such as Chlamydia (dirty wet bottom) and/or conjunctivitis (puffy, weepy red eyes).

#### **Toondah Koalas - Ruby and baby Eclipse**

In late May, a baby koala (approx. 7 months old) was found at the base of a tree in GJ Walter Park at Cleveland.

An adult female named 'Ruby' was discovered in Carina Heights, Ferny Grove, Holland Park a tree nearby and after an unsuccessful attempt to West. GCCC: Reedy Ck. MBRC: Bunya, reunite them, they were taken to Australia Zoo Wildlife Hospital for vet checks and fortunately were given a clean bill of health.

> Whilst Ruby was under anaesthetic (which is a requirement for an examination) baby Eclipse was placed back into her pouch and after a short while she snuggled in and the reunion was deemed a success.



Ruby and Eclipse were released back into their

'home range' a day later and have been seen since hanging out in trees near Toondah Harbour.

#### Is the Birkdale Land to be used for Mayors Olympic Dream?

The media announcement this week that Redlands will host a white water rafting facility for the Olympic Games in 2032 gives the appearance the recent community consultation conducted by Council on the Birkdale Land was nothing more than a farce.

Council's community consultation feedback closed on May 4 and surprisingly a little over three weeks later on May 27 an 'Extraordinary Meeting' was held to discuss the community feedback results that numbered in the thousands.

webcast.redland.qld.gov.au/ archive/video21-0527.php shows the depth of determination of Mayor Williams and her

supporters to ensure the Olympic venue was at the top of the agenda even though the community feedback results suggested otherwise.

The 'Results Snapshot' (at right) provides a summary of the feedback received via the online survey and various in-person consultation events conducted by Council.

Whilst it was pleasing, but not surprising to see that wildlife and the natural environment were at

the top of the preferred use list, questions remain about the flawed grouping of 'water play' with 'Olympic standard white water facility'.

Survey participants who selected 'water play' may not have necessarily supported the 'Olympic standard' venue, however it appears these options were counted as one of the same choice.

This appears to have been a deliberate tactic to achieve a specific desired outcome.

The community must be fairly asked whether they support an Olympic venue on the Birkdale land.

KAG firmly believes such a large entity does not fit in with the rich heritage, cultural and environmental values of the site.

Furthermore, serious questions must also be asked about whether this move breaches the conditions of the Environmental Agreement signed between the Federal Government and Council (upon sale of the land) and compromises the significant environmental constraints that apply to the site.

Figure 4 details the top 12 ideas for both in-person and online engagement activities, from quantitative questions. The differences between the two may be related to a number of factors, including the difference in the number of options participants could select. For in-person activities, like the dotmocracy activity, the participant selection was limited to five compared with the digital questions where selection was unlimited. Additionally, the dotmocracy provided a greater diversity of options that were used to distill the specific ideas.

It is also reasonable to ask RCC to provide a business case that considers the future cost and engineering implications of this project which could end up being a "white water elephant" for Redland rate payers.

### Recycling in the Redlands - did you know?

**IndigiScapes Recycling Station** - thongs/flip flops, toothbrushes, empty toothpaste tubes, old art supplies (paint and brushes), beauty products, VHS cassette tapes, CD's, DVD's, mobile phones, x-rays, small e-waste, LOL surprise toys and packaging.

**RecycleWorld (Redland Bay Waste Transfer Station)** - second hand items that are in very good condition.

Birkdale Waste Transfer Station - scrap metal, gas bottles, lead acid car batteries, e-waste, polystyrene, bricks, concrete, greenwaste,

untreated timber, waste mineral/cooking oil, household recyclables (firm plastic, metal, glass, paper, cardboard).

**Officeworks** - biros, highlighters, colouring markers, ink/toner cartridges, keyboards, laptops, cables, mice, portable hard drives, DVD's, CD's, USB flash drives, memory cards, mobile phones, mobile chargers and cables, smart watches, mobile phone batteries and household batteries.

Aldi - household batteries (all sizes)

**Ocean Crusaders** - plastic bottle tops/lids (certain types only - see website below for guidelines) https://oceancrusaders.org/recycling/

**Coles/Woolworths** - shopping bags (including reusable green bags), fruit/veg bags, frozen food and bread bags, cereal, chip, biscuit, confectionary, rice and pasta packaging (including silver lined), zip lock bags, soft plastic packaging/bubblewrap from deliveries, potting mix/compost bags, squeeze baby food/yoghurt pouches, dog/cat food pouches, meat and food wrapping, clear wine/water bladders, Aust Post plastic satchels, cellophane from flowers, document sleeves, netting produce bags (remove metal clips), clingwrap (GLAD, Coles and Woolies homebrand only)

**Note:** Soft plastics only, rinse food product from wrapping and dry, cut larger plastic pieces into A3 size.
