State Government grants permit for koala to be removed from **Ormiston site**

KAG recently learnt that the Qld State Government Department of Environment and Science granted permission to the developer of a site in Cowley Street, Ormiston to have a resident koala captured and moved elsewhere.

Widespread media from the ABC earlier this year highlighted significant flaws in Redland Council's habitat protection legislation that allowed numbers of 100 plus year old koala trees to be bulldozed on the development site where at least three koalas lived.

The tree removal was only halted at that time by the ongoing presence of koalas on the site as legislation prohibits the removal of trees that contain koalas.

The permit was granted under the State Government's Policy on 'Release of rehabilitated Koalas and the release of koalas in imminent danger'.

KAG strongly believes that in this instance the Policy has been abused and sets a dangerous precedent of what is perceived as 'imminent

danger'.

Any koala living in an urban environment could now be seen as being in 'imminent danger'. The State government has opened the flood gates to having all urban koalas potentially removed under this flawed and irrational 'appease the developer' policy.

KAG wrote to the State Government on August 16 (see below) to express our concerns and has not received a response at the time of printing this newsletter which is more than a month later.

expressed serious concerns regarding the risk for it to be misused and although we were assured that this would not be the case it now appears this is what is occurring.

KAG believes the koala currently living on the Cowley Street site is not in 'clear and imminent danger' as it is residing in a number of significantly large Eucalyptus Tereticornis trees and can move away from the site on its own accord if it so chooses and we are aware of at least four other koalas over the past 12 months that have also been utilising the site.

Our group understand that this urban population of koalas move in and out of the area by using habitat trees on footpaths and in the adjoining parkland to move to the nearby Ormiston Primary School, foreshore trees and patches of remnant bushland that are located to the north, south, east and west of the site.

We request that your department provides the reasons for giving the developer a permit to remove this koala and also the evidence to prove that the koala is in 'clear and imminent danger'?

Koalas with bling - what are ambassador koalas in the Koala Safe Neighbourhoods wearing, and why? - by Dr Romane Cristescu USC

For those of you who may have seen koalas in your neighbourhood adorned with collars and/or ear tags, these koalas are part of a tracking project from the Redland City Council and the Detection Dogs for Conservation at USC (University of the Sunshine Coast)

For the past three years, a number of koalas in the Redlands have been recruited as ambassadors of their respective Koala Safe Neighbourhoods (Ormiston, Birkdale, Thornlands and selected areas in Mount Cotton).

All koalas are given a health check by USC's partnering vet team at Endeavour Veterinary Ecology, and then fitted with multiple tracking devices attached to collar to answer a variety of questions that help to understand and protect them better.

The monitored koalas are also microchipped to enable identification if a koala is recaptured (such as in case of an injury/disease later in life) after the monitoring is over.

In general, questions such as where koalas are, how much time they spend in each part of their home range (territory), how they move and navigate the urban matrix and how far they go during a day, a week, or when they disperse, are all important to assess the threats they face, and which areas they rely on most. This understanding of koalas can help RCC environmental

managers to design effective conservation plans and prioritise areas to protect.

Primarily, the monitoring devices are used to find koalas regularly, and check their health conditions and welfare. The sooner a sick or injured koala is found, rescued and treated, the higher the chances of recovery and release back into the wild.

The collar assembly is customised with a safety weak link (designed to break if the koala becomes entangled). Collars weigh less than 300g and contain several technologies. A GPS tracker is used to record the animal's location every 6 hours and display it to researchers in near real time, so they can ensure they know



where koalas are moving. This is checked daily. The GPS tracking data is a powerful tool and has been used to highlight some of the tricky situations koalas find themselves in.

A good recent example is GPS data of koala 'Rainbow' frequently crossing rail lines at Birkdale has triggered a partnership with Queensland Rail to work with researchers and the council to find solutions to mitigate koalas interacting with the rail line in that area.

A small lightweight altimeter is used to detect when koalas are on the ground. This will quantify for the first time how long koala spend on the ground while moving between trees. This is critical for their protection, as the ground is where koalas are at their most vulnerable (think dog attacks, car collision).

A VHF beacon allows researchers to find koalas at any time, when performing field assessments to check koala health.

Finally, koalas are equipped with a solar-powered Bluetooth ear tag (<5g). This newly developed tag allows researchers to identify koalas while standing near the base of its tree.

Over the past three years, the Redland City Council and the Detection Dogs for Conservation at USC have monitored 40 individuals and taken 12 koalas for treatment to Australia Zoo Wildlife Hospital. Each interaction brings important information about the daily lives of Redlands koalas.

Councils' Birkdale Land Olympic vision not community choice

At a meeting on August 22nd, a majority of councillors voted to adopt the 'vision plan' (below) for the Birkdale Land that features an aquatic centre and whitewater facility despite community feedback indicating that it was one of the least preferred uses for the site.

It has been revealed that less than 10% of survey participants on the Council's online feedback form supported any type of Olympic venue to be built on the Birkdale Land, yet the draft vision plan shows an Olympic whitewater rafting facility as a centrepiece for the site.

This extraordinary disregard of public opinion from Mayor Williams and a number of supporting councillors displays complete disrespect for the thousands of community members who made an effort to participate in the survey.

It gives the appearance that the preferred use for the site had been predetermined and a farcical community consultation was carried out at a significant cost to rate payers.
